
Abby Lee Miller, former "Dance Moms" host, filed for bankruptcy in 2010, owing more than \$400,000 in unpaid real estate taxes. In 2015, Abby was charged with bankruptcy fraud in concealing income from the "Dance Moms" TV show. She hid \$775,000 received in 2012 and 2013 from the show, related spinoffs, dance instruction sessions, and merchandise sales by creating secret bank accounts and instructing others to conceal income.

### "Dance Moms' Abby Lee Miller Fraud Case"

## <u>Speaker: Gregory Melucci, Assistant United States Attorney, Economic Crimes Section,</u> <u>Office of United States Attorney, Western District of Pennsylvania</u>

In 2017, Abby was sentenced to one year and one day in federal prison, followed by two years supervised release. She was also fined \$40,000 and ordered to pay \$120,000 judgement. During this presentation, Assistant U.S. Attorney Gregory Melucci will share his first-hand account of prosecuting this case.

Gregory Melucci has been an Assistant United States Attorney for the Western District of Pennsylvania since 2006, and currently serves in the newly created Economic Crimes Section. He has prosecuted a variety of financial fraud schemes, including bank, wire and mail frauds, identity theft crimes, tax frauds, counterfeit credit card schemes, employee embezzlement, Ponzi schemes, bankruptcy frauds, cyber frauds, as well as frauds perpetrated through the internet such as romance scams, and business email compromises. He chairs the Financial Crimes Task Force of Western Pennsylvania, the Bankruptcy Fraud Task Force, and the Identity Theft Fraud Working Group for the Department of Justice. He also coordinates the SAR working group for the district.

His notable prosecutions include convictions against "Dance Moms" TV star Abby Miller for bankruptcy fraud and structuring foreign currency, convictions against several Cuban nationals who perpetrated a multi-national tax fraud money laundering scheme, and a conviction against an insurance agent who perpetrated a \$10 million investment-Ponzi scheme. He is a graduate of the Dickinson School of Law, and Washington and Jefferson College.
